One night while the Americans were in camp on Assanpink Creek, at Trenton, N.J., Comer was placed on guard duty with orders to hail any strange person three times and then to fire unless answered. An officer who thought he would have some fun with Comer and stampede him got down to the brink of the creek and threw up firebrands. The sentinel was alarmed but obeyed his orders and fired, wounding the officer. Comer was placed under arrest but exonerated by General Washington. This is an excerpt from Pvt. Augustine's recorded history!
