Fred Hill of the Freedom Chapter gave us a well prepared presentation on Black Powder/ Small Arms. The members of our chapter enjoyed the presentation and had many questions for Fred! Fred was presented the Certificate of Appreciation for his presentation.

The Patriot of Jim Cantrell: William Cage was born in Virginia 1745. He removed to Chatham County, North Carolina, and served for a time as a Major in the Continental Army. His chief service was against the Tories under Colonel David Fanning. He was taken prisoner by the Tories for a short time. At the conclusion of the fight for Independence, he removed to Sullivan County, North Carolina. He was a delegate to the House of Commons North Carolina Legislature in 1783 and was returned the succeeding session. He voted against the First Session Act, but became one of the moving spirits in organizing the new State of Franklin. He was elected Speaker of the House of Commons and was the first Treasurer for the State of North Carolina. In 1785, he removed to Sumner County, North Carolina. He was appointed Sheriff of the County by Governor Blount in 1790 and held that post until 1796. He was succeeded by his son, James Cage. William Cage died at home in Cage's Bend (of the Cumberland River), Gallatin, Tennessee. His tombstone bears the inscription: William Cage, A Major in the Revolutionary War. Died March 12,1811.
