

#### **PROGRAM**

President Hugh Ferguson gave an excellent presentation on his Acadian Revolutionary Ancestor, Jean Baptiste Chiason. Jean Baptiste ("Jonas") was born in Nova Scotia of French parents. After imprisonment by the British during the French and Indian War, he and his parents fled to France where he was soon orphaned. He returned to North America and joined the Colonial Army in 1775 at Quebec. He served with Lafayette at Brandywine in 1777; fought at Germantown in 1777; was wounded at Eutaw Springs in 1781; and fought under Lafayette's command at Yorktown in 1781. In 1785 he migrated to Western Louisiana as a cattle rancher and farmer, married Marie LeBlanc and had eight children. He later moved to Beaumont, TX with his son until his death in 1854. He was one of few men in the American Revolution involved in Texas history. He is a recognized Patriot by both the SAR and DAR.
